Message to Our Community

The Saskatoon Preschool Foundation continues to uphold the mission to advocate for and support access to preschool programs by granting tuition subsidies for children of families with financial barriers.

SPF advocates for access to quality preschool programs because they provide an ideal foundation for early literacy skills, support language and social skill development and foster a readiness for school attitude. Attendance in early education classrooms contribute to a child's social, physical, and intellectual development. Moreover, families have an opportunity to build community in their neighbourhood and with the school.

Advocacy was a prime focus during 2022 as the Saskatchewan government received Federal funds to initiate \$10 a day childcare. Jean Bacon and Kathy Harrison, on behalf of SPF, participated with several like minded groups such as Childcare Now and SECA, to learn more of how this would impact preschools in our communities. What has been learned is that preschools are not included or seen as alternate Early Learning opportunities. It was also learned that SPF does not have a broad enough scope in gathering information to advocate with the government. SPF has built a relationship with the Saskatoon Teachers Group. The Saskatoon Teachers Group has created a survey that would be sent out to Preschools in early 2023, primarily in the Saskatoon area but with hope to send more province wide, to capture data that might be of use in conversations with the Ministry of Education. Grant writing and corporate donors are two areas that require a great deal of time and energy. It was decided that for the 2022-2023 school year to take a break from grant writing to refresh and re-evaluate. SPF acknowledged that this could result in a need to utilized additional funds directly from principal investment. SPF continues to have one staff member who works remotely from a home office. This has worked well and there are no current plans to relocate to a physical office space.

The SPF board members are active volunteers determined to work diligently together. We are a diverse team of individuals that together use our time and talents to ensure the purpose of the Saskatoon Preschool Foundation carries on. Thank you for your continued commitment to SPF.

A warm thank you to all our corporate, special interest and individual donors. Your support and generosity truly helped guide SPF through the challenges of 2022. We appreciate your consistent and valued trust in our mission to provide high quality preschool to all in need in Saskatoon.

Advocacy

The work of the Advocacy Committee evolved into a focus on two main areas in 2022:

- Promotion of the availability of preschool tuition subsidies with families and preschools; and, •
- Advocating for the inclusion of community preschool* as an option within the federal/provincial early ٠ learning and child care (ELCC) agreement targeting \$10/day.

Regarding the availability of preschool tuition subsidies, ensuring that families' awareness of subsidies has come into sharper focus over the last two years. During the calendar year prior to the pandemic (2019), the SPF provided over 120 subsidies (total over \$90,000). In the past years, the number of applications was reduced to an average of 45 (total: \$40,000). While there was a slight increase in applications in 2022, the number is far below the number in the years prior to the pandemic with reasons for this unclear. However, there are these possibilities:

- In conjunction with the Saskatoon Preschool Teachers Group, a survey of community preschools is in **progress.** The results will provide information regarding the number of community preschools that remain open, the number of spaces left unfilled, the number of children on waiting lists, etc.
- Some prekindergarten programs within school divisions have been relocated to schools where there were community preschools, effectively taking their place.
- With the reduction in the cost of childcare as an outcome of the federal/provincial agreement, some families ٠ may be choosing full- or part-time ELCC instead of community preschool.**

Advocating for the inclusion of community preschool as an option with ELCC is a main focus. Provincial education regulations in Saskatchewan* do not include licensing community preschools. British Columbia, Alberta and Manitoba regulations have preschool licensing requirement and fees for community preschool in these provinces (a fraction of full time) are recognized on a proportional basis for childcare subsidies. In fact, in Ontario and New Brunswick, four-year-old children attend full day kindergarten at no cost to families.

A number of provincial organizations are providing leadership in bringing the federal/provincial agreement to life in Saskatchewan:

- The Saskatchewan Early Childhood Association, •
- Child Care Now Saskatchewan (affiliated with Child Care Now Canada) and •
- The Saskatchewan Early Learning Leaders Caucus (affiliated with Canadian Child Care Federation). These groups support the SPF's efforts in promoting community preschool as an ELCC option and have invited representatives of the SPF to be part of their meetings as representatives of the community preschool sector.

Messaging from early learning and childcare organizations is focussed on transformational change in two main areas including an expanded commitment from the government to ensure that:

- Employment in ELCC is highly valued with increasing educational opportunities and improving salary and benefits for those employed in the field. There is a huge gap in the number of spaces the government has announced as its goal and the number of spaces that can be made available with the current workforce numbers.
- There is a distribution of ELCC spaces all areas of cities and the province. Currently, centres open where they • can find space, not necessarily in the communities where the spaces are needed.

In 2022, SPF board members engaged in the following activities to ensure awareness of preschool tuition

subsidies for children in low-income families and securing provincial funding for community preschool programs:

- Distribution of tuition subsidy posters in offices, stores, and malls throughout the city ٠
- Meeting with the Ministry of Education Early Learning and Child Care Branch
- Communication with various groups and agencies: Greater Saskatoon Catholic, Saskatoon Public, and Prairie Spirit School Divisions, Saskatoon Public Libraries, Saskatoon Preschool Teachers Group, Kids First Saskatoon, Saskatoon Family Centres, the Children's Advocate, Open Door Society, Global Village, among others SPF 2022 ANNUAL REPORT 4

- **Posting information on the SK 211 website** regarding preschool subsidies and encouraging preschools to place their information on the website as well
- **Providing information for families and preschools** regarding possible avenues of support for preschool for children with special learning needs.
- Maintaining the SPF website (<u>www.spf.sk.ca</u>)
- Placing an advertisement in the 2022 City of Saskatoon Leisure Guide.

Please support our work in ensuring that families of preschool children are aware of the SPF tuition subsidy opportunity and in having community preschool recognized for funding as an option for early learning and childcare.

*Community preschool is typically less than 3 hours/day on the days its provided, from 1-5 days/week, with no before and after school care or care during school year holidays.

**The long-term goal of reducing childcare costs to \$10/day was achieved April 1, 2023. The goal of a special lower rates for families with low income is to be achieved by 2025.

In 2022, we received and approved 45 subsidy applications. Applicants attended 20 different preschools in Saskatoon and surrounding area.
